**The Eastern Ontario Wardens' Caucus Advocates for
Regional Priorities at ROMA 2024 Conference**

January 25, 2024, Eastern Ontario – The Eastern Ontario Wardens' Caucus (EOWC) continues to advocate strongly for regional priorities at the Rural Ontario Municipal Association (ROMA) 2024 Conference held in the City of Toronto from January 21 to 23, 2024.

From across Ontario, the EOWC joined over 2,000 rural municipal colleagues at the conference to participate in meetings with provincial Ministers, Members of Provincial Parliament, and the Ontario New Democratic and Liberal opposition parties to discuss critical priorities including:

- Affordable and attainable housing
- Next generation infrastructure funding
- Long-term care
- Modernizing the construction approval process
